

The Society for the Study of Medieval Languages and Literature has awarded the *Medium Ævum* Essay Prize since 2008. The competition is run annually, with postgraduates and those recently graduated with a higher degree invited to submit an essay on a topic that falls within the range of the interests of *Medium Ævum* in the medieval period (loosely defined as the fifth to the fifteenth century, in the Western calendar).

Submission

An essay, of no more than 8,000 words, on a topic in the range of interests of *Medium Ævum*, received by 12:00 midday (GMT) Monday 1st December, 2025

The Prize

- The value of the prize is £500
- An entry declared *proxime accessit* will be awarded £100

The winning essay and other entries of sufficient quality and promise may be considered for publication in *Medium Ævum*

Eligibility Criteria

A competition for unpublished work of postgraduates and those recently graduated with a higher degree
